

House Rules of the Organiser
ART Kunstmesse GmbH

(Valid during the opening hours of the ART Salzburg Contemporary & Antiques)

By entering the exhibition grounds, the visitor agrees to the terms of the following House Rules of the Organiser:

1. The venue shall be considered the designated locations of the Messe (fairgrounds) Salzburg.
2. Children up to 14 years are only admitted when accompanied by a guardian.
3. Crowding may cause circulatory weaknesses and injuries, for which the Organiser assumes no liability. The Organiser does not assume any liability for items brought along either.
4. The respective originator is liable for damages caused by visitors to objects such as exhibits, furnishings and equipment, or at the venue.
5. Notify the Organiser or the supervisory and safety staff immediately about accidents or damage events.
6. It is generally prohibited to bring glass containers, pepper sprays, plastic canisters, pyrotechnic items, torches, compressed air horns, megaphones, and posters/banners with offensive, political or racist content, as well as weapons of any kind. Failure to observe these instructions leads to the expulsion from the exhibition grounds.
7. The supervisory and security staff is authorized to frisk persons who want to enter the exhibition grounds for dangerous or prohibited items as well as for containers brought along. In case of doubt, the competent security officer classifies the goods as prohibited or allowed in compliance with these terms and conditions.
8. The supervisory and security personnel is entitled to deny access to the venue for persons who refuse a body check or want to bring dangerous or prohibited items to the exhibition grounds. Access is also denied for visitors, who are regarded as known or potential troublemakers, or are obviously under the influence of alcohol or drugs.
9. We reserve the right to deny access for cause.
10. All persons who enter the exhibition grounds, have to behave in such a way that no other persons are injured, damaged, compromised, impeded or harassed.
11. For the maintenance of order and security, it is required to follow immediately the instructions of the supervisory and security personnel or the police. Failure to observe these instructions or disregard of the access rules will be punished and leads to the expulsion from the exhibition grounds.
12. Please dispose waste, packing materials and empty containers in the designated waste containers.
13. The commercial usage of audio, photo, film and video recordings is forbidden without the written consent of the Organiser. Any misuse will be prosecuted.
14. Persons who spread right-extremist slogans or wear such symbols are excluded from the event.
15. No claims whatsoever shall be raised, when the event is terminated or parts of it are cancelled due to force majeure, in particular bad weather.
16. In the case of unforeseen events, such as heavy rush, overcrowding of one or more venues, emergency situations, shortages, dangerous and too dense formation of crowds, as well as other security-related incidents, the Organiser is entitled to temporarily or partly restrict or completely prohibit access to individual venues. The Organiser gives no guarantee or

warranty whatsoever that all venues are immediately and fully accessible at any time during the event.

17. It is at the discretion of the Organiser to block off individual areas within the exhibition grounds.
18. The Organiser reserves the right to change the program without prior notice.
19. The Organiser is not responsible for lost and / or stolen items.
20. When entering the exhibition grounds, the visitors agree to be filmed or photographed, to raise no objection to any publication live or at a later date, or to put in no claims in this context to the Organiser or its contractor.
21. All upward and downward staircases as well as the escape ways and emergency routes must be kept clear. If necessary, other requirements may be imposed on a case-by-case-basis in order to prevent or eliminate danger to life, health or property. Visitors must follow such instructions imposed for this purpose, which are given by the supervisory and security personnel or the police.
22. The distribution of flyers, stickers, magazines or the sale of goods of any kind must be authorized by the Organiser.
23. It is strictly prohibited to bring promotional materials of any kind (e.g., banners, brochures, newspapers, etc.) to the venue.
24. Entering the exhibition grounds with clothes that cover the face, is prohibited.
25. For security reasons, no skateboards, in-line skates, ladders, stools, scooters or other bulky items, which are not meant for the transportation of physically disabled persons, may be brought into the exhibition grounds or used in there.
26. Visitors must observe the Tyrolean Youth Protection Act in any case.
27. Where good cause exists to do so, in particular in the event of offences committed by visitors, the Organiser or the security company commissioned by the Organiser is entitled to exclude such visitors from the event.
28. Visitors are requested to leave long coats, cloaks, umbrellas, backpacks or large bags in the cloakroom.
29. Smoking is allowed only outside the main entrance, in the designated areas.
30. Dogs must be kept on a short leash without exception. Dog owners shall be liable for any damages caused by their dogs.
